What is Georgia Pathways to Coverage™?

In 2023, Georgia's Department of Community Health (DCH) launched Georgia Pathways to Coverage™, a Medicaid eligibility category that seeks to increase access to affordable, quality healthcare coverage for people who would not otherwise be eligible for traditional Medicaid.

To be eligible for Pathways, an applicant must:

- Be a Georgia resident
- Be a U.S. citizen or legally residing non-citizen
- Be between 19 and 64 years of age
- Have a household income of up to 100% of the Federal Poverty Level (FPL). For example, in 2025, this equals:
 - \$15,650 per year or \$1,304 on average per month for one person
 - \$26,650 per year or \$2,220 on average per month for a family of three
- Complete at least 80 hours of qualifying activities per month
 - For Pathways applicants fulfilling the requirement through higher education, current college course-load credit hours will be granted qualifying activity hours as following:
 - At least 11.5 credit hours will count as 80 hours per month
 - Between 5.50 and 11.49 credit hours will count as 40 hours per month
 - Between 0.01 and 5.49 credit hours will count as 20 hours per month
- Not qualify for any other type of Medicaid
- Not be incarcerated

Qualifying activities include full-time or part-time employment, on-the-job training, job readiness assistance programs, community service, vocational educational training, enrollment in the Vocational Rehabilitation program of the Georgia Vocational Rehabilitation Agency (GVRA), and higher education through enrollment in public and private universities and technical colleges.

How Can Your Organization Participate?

As a trusted voice for local communities in Georgia, your organization is in a unique position to help connect potentially eligible individuals to Pathways. Pathways is a category of Medicaid coverage for many of the individuals you already support in their journey to employment, education, and professional development. To be eligible for Pathways, an individual must complete at least 80 hours of qualifying activities per month. Attending your institution, participating in your program, or working at your organization provides ways for potential Pathways members to meet their hours and/or prepares individuals to meet their hours. You are likely already working with Georgians who are Pathways eligible and/or are a resource to support individuals who are seeking to become eligible.

It is our hope that you will be a resource to members or potential members who reach out for support. We ask that you support Pathways members as they complete or seek to complete their required 80 hours a month of qualifying activities and encourage them to report their hours on time. This will help Pathways members gain and stay enrolled in healthcare coverage.

Pathways seeks to increase access to affordable, quality healthcare coverage, lower the uninsured rate across Georgia, support participating members on their journeys to financial independence, and promote members' transitions from Medicaid into private coverage.

Did You Know?

- Pathways offers healthcare coverage to residents who meet program requirements, including participation in qualifying activities, and are not otherwise eligible for traditional Medicaid.
- There are many ways to meet qualifying activity requirements for Pathways including full-time or part-time employment, on-the-job training, job readiness assistance programs, community service, vocational educational training, enrollment in the Vocational Rehabilitation program of the Georgia Vocational Rehabilitation Agency (GVRA), and higher education through enrollment in public and private universities and technical colleges.
- Pathways offers multiple ways to apply and report changes, including online, in-person at any DFCS office, by mail, or by phone.
